Important Notice Change of Auditor

This Notice is to inform you that there will be a change of auditor for both the registered and unregistered schemes ('Funds') listed on page 2 for which Mercer Investments (Australia) Limited ABN 66 008 612 397, AFSL 244385 ('MIAL', 'we', 'us' or 'our') is the Responsible Entity.

MIAL has received approval from the Australian Securities and Investments Commission to appoint Deloitte Touche Tohmatsu ABN 74 490 121 060 ('Deloitte') as the new auditor for both the Financial Statements and Compliance Plans.

As a result, MIAL has approved the resignation of PricewaterhouseCoopers ABN 52 780 433 757 ('PwC') as the auditor for the Funds and the appointment of Deloitte as the new auditor for the financial year commencing 1 July 2024. The appointment of Deloitte was made following a commercial tender process.
