Investor update

Distribution and transaction processing timetable for 31 December 2024

This update is to inform you of the timetable for transaction processing and distribution payments for the following:

- Advance Investment Funds
- Mercer Funds
- Mercer Indexed Funds
- Mercer Multi-manager Funds
- Managed Portfolio Series Funds (CoreSeries).

These are collectively referred to as ‘the Funds’. A detailed list of the Funds covered by this update is included in the table commencing on page 3.

Transaction processing delays from 1 January 2025

In January each year, we delay the calculation of daily unit prices for up to 10 business days to finalise the distributions for each Fund. Daily unit pricing will recommence once the distribution for a Fund has been finalised and (if relevant) paid.

During this period, we will continue to accept application and withdrawal instructions. However, these instructions will only be processed when we recommence daily unit pricing and have calculated the daily unit prices for this period. Any applications and withdrawal instructions received on a day during this period will be processed following the end of this period using the relevant unit price for that day. For example, if an application is received on Monday 6 January prior to 3pm, it will be processed at a later date (up to Wednesday 15 January, depending on the Fund) using the unit price calculated for Monday 6 January.

As withdrawals will be processed once unit pricing has recommenced, payment of withdrawal proceeds will also be delayed. Applications are unaffected by the delay since they will be processed using the unit price applicable to the day of the application.

Timetable for 31 December 2024

The Funds have been arranged into three processing groups to allow for the efficient processing of distributions. For a list of the Funds in each group, please refer to the table on page 3.

The table below provides the estimated dates for processing distribution payments (if relevant) and the recommencement of daily unit pricing and transaction processing for each processing group.
