What type of investor could this portfolio suit?

Mercer CoreSeries Active Balanced Portfolio could be suitable for an investor with a minimum five year investment horizon with a medium to high capacity tolerance for risk, and who is looking to grow their wealth over the long-term and willing to ride out short-term market fluctuations.

Investment Objective	To provide moderate to high total returns over the medium term from a combination of capital growth and income through a diversified mix of growth and defensive assets. The portfolio aims to earn a rate of return that exceeds the Consumer Price Index by at least 3.5% pa over a rolling 5 year period (net of fees and costs).			
Investment Strategy	The portfolio invests in a diverse mix of assets with both growth asset classes such as equities, property and infrastructure of around 70%, and defensive asset classes such as cash and fixed interest securities of around 30%.
