

5 ways to grow

Select a Portfolio

You can select from five different Mercer CoreSeries Passive Portfolio profiles depending on the needs of your clients.



Mercer CoreSeries Passive Conservative Portfolio

Seeks to deliver predominantly income and some growth returns with a low probability of loss over the short term. The portfolio aims to track the overall return of a diversified portfolio of underlying investments.

The majority (approximately 70%) of the investment is in defensive investments.

Minimum suggested investment timeframe 3 years



Mercer CoreSeries Passive Moderate Portfolio

Seeks to deliver a combination of predominantly income and stable growth returns. The portfolio aims to track the overall return of a diversified portfolio of underlying investments.

The investment is in both defensive (approximately 50%) and growth-oriented (approximately 50%) investments.

Minimum suggested investment timeframe 4 years



Mercer CoreSeries Passive Balanced Portfolio

Seeks to deliver predominantly moderate growth and some income returns. The portfolio aims to track the overall return of a diversified portfolio of underlying investments.

The majority (approximately 70%) of the investment is in growth-oriented investments.

Minimum suggested investment timeframe 5 years



Mercer CoreSeries Passive Growth Portfolio

Seeks to deliver predominantly moderate to high growth and some income returns. The portfolio aims to track the overall return of a diversified portfolio of underlying investments.

The majority (approximately 85%) of the investment is in growth-oriented investments.

Minimum suggested investment timeframe 6 years



Mercer CoreSeries Passive High Growth Portfolio

Seeks to deliver predominantly high growth returns. The portfolio aims to track the overall return of a diversified portfolio of underlying investments.

The majority (approximately 98%) of the investment is in growth-oriented investments.

Minimum suggested investment timeframe 7 years



How are Mercer CoreSeries Passive Portfolios managed?

Mercer is the investment manager for the portfolios, providing investment products and solutions across a range of asset classes, including shares, property and fixed interest.

Mercer CoreSeries Passive Managed Portfolios are constructed according to Mercer's robust research and risk management process which combines quantitative and qualitative analysis. Mercer CoreSeries Passive Portfolios are assembled using a range of index funds and exchange traded funds, each selected to play a specific role in terms of income, growth and diversification, within each risk- based profile.

Asset class ranges have been set to allow for the flexibility to adjust to changing market and investment circumstances. Final decisions are determined through the team's investment process, combining peer review and Investment Committee approval.

Minimum cash holdings may be determined by the relevant platform provider. Mercer's investment team factor this in as part of the asset allocation decision-making within the portfolios.

The Investor Directed Portfolio Services (IDPS) operator of the Managed Portfolios rebalances all managed portfolio options regularly, establishing minimum transaction levels to protect against unnecessary costs and impact to clients. You can access all information and reporting for your clients' investments through the selected IDPS platform.

Invest with insight

Underlying funds for the Mercer CoreSeries Passive Portfolios

Mercer's investment team uses index funds in the strategy to provide exposure to each asset class. ETFs may also be used.

The table below provides details of the asset class and current underlying fund exposures. Allocations to the below funds vary between Mercer CoreSeries Passive Portfolio options. Funds may be added or removed from time-to-time.
