Overview of the changes:

Western Asset Management Company Pty Ltd ('Western Asset Management') has been terminated as an investment manager from the Advance International Fixed Interest Multi-Blend Fund (ARSN: 094 108 924, Wholesale Units APIR: ADV0067AU, Retail Units APIR: ADV0088AU) ('the Fund') with effect from 21 November 2024.

The proceeds from the termination have been reallocated to other managers within the Fund, namely:

- · Insight Investment Management (Global) Limited
- · PIMCO Australia Pty Ltd, and
- Wellington Management Australia Pty Ltd.


